

## Cooke-Yarborough Almshouse Trust

**Information**The Trust is a registered charity managed by Trustees appointed by the Parochial Church Council of the Parish Church of St Leodegar Wyberton. It has a pair of single bedroom semi-detached bungalows with living room, kitchen and bathroom. There is a garden to the rear (which the occupant is responsible for maintaining in good order) and lawns to the front (maintained by the Trust).

**Almshouses** are occupied under licence and the occupant will pay a maintenance charge, comparable to the Social Rent calculation of the local Housing Association. This is currently (April 2022) £300 per calendar month, paid in advance. In the event of a number of applications the Trustees will select suitable tenants in accordance with the aims of the charity. Applicants should meet the following criteria

- a. Currently in receipt of State Retirement Benefits (OAP)
- b. Currently resident in the Parish of Wyberton **or**
- c. Previously resident or born in the Parish of Wyberton **or**
- d. Can demonstrate strong personal ties to the Parish of Wyberton
